The Winner will be notified via email or phone April 20, 2018, to the email address or phone number provided at the time of loan application. Odds of winning will depend on the number of eligible entries received.

PRIZE: There is one (1) Amazon Fire Tablet with case prize. Prize will be disbursed to the winner before or on May 1, 2018. Winners will be responsible for any federal and/or state tax that may apply; please confer with a taxadvisor.
